


## Senate & House Composition

#### » Senate: Republicans Retained Thin Majority

- Senate Republicans still need 8
   Democrats to get to 60 for procedural votes, but nevertheless are poised to try and move key Administration priorities with control of two branches.
- \*Louisiana seat faces a December runoff.

#### » House: Republicans Maintained Their Majority

- Democrats had a net gain of 6 seats
- Republicans gained 3 and lost 9 incumbents (as of print)
- 218 needed for chamber majority
- \*Republicans will likely win the one outstanding Louisiana seat




With 1 race outstanding: Republicans = 240\* seats Democrats = 194 seats



## Administration Transition: Secretary of Transportation Nominee



- » Elaine Chao, the 24th U. S. Secretary of Labor who served from 2001-2009, is the first American woman of Asian descent to be appointed to a President's Cabinet in our nation's history. She is the longest tenured Secretary of Labor since World War II, and the only member of President Bush's original cabinet to have served the entire eight years of his Administration.
- » Secretary Chao's career spans the public, private and non-profit sectors. She has worked with United Way of America, the Peace Corps, as Deputy Secretary at the U.S. Department of Transportation, Chairman of the Federal Maritime Commission, Deputy Maritime Administrator, White House Fellow at BankAmerica Capital Markets Group, and Citicorp.
- » Secretary Chao earned her MBA from the Harvard Business School and an economics degree from Mount Holyoke College.


- **Jan. 20, 2017:** 45<sup>th</sup> President-elect's inauguration at noon
- Feb. 6, 2017: President is required by Public Law 101-508 to submit a budget request by the first Monday in February; there's no penalty for missing the deadline.
   (Trump Administration will most likely submit budget in April.)
- **Feb. 15, 2017:** Congressional Budget Office (CBO) is required to release its annual budget estimate.
- March 15, 2017: Debt ceiling comes back into effect; when borrowing authority has lapsed in the past, the Treasury Department has used so-called extraordinary measures to avoid defaulting on government obligations.

### Lame Duck Session Overview

- End-of-the-Year Spending Bill: House and Senate are going to pass CR through April 28 funding government at current funding levels.
- Water Resources Development Act (WRDA): Passed by the Senate on September 15, and the House passed their version of WRDA on September 28. Conference report released on December 5. House will pass it the week of December 5. Unclear on Senate timeline due to EPW Committee Ranking Member Boxer's opposition to CA drought provision.
- 21st Century Cures Act/Mental Health/Criminal Justice: House passed legislative package that includes provisions related to criminal justice, mental health, and addiction legislation on November 30. Senate expected to pass legislation soon.

## 2016 Key Accomplishments

#### » TIGER Grant for Regional Complete Streets

- Helped secure \$11,443,371 in TIGER funds.
- DOT received 620 eligible applications for this round, and chose only 40 projects.
- Only TIGER grant awarded in the state of Florida.
- H&K arranged a debrief call with DOT, reviewed application, coordinated congressional letters of support, drafted talking points, and arranged a call between delegation and DOT Secretary Foxx to highlight the project.

#### » Fixing America's Surface Transportation (FAST) Act

- Signed into law on December 4, 2015.
- Five-year authorization of the federal surface transportation programs, including federal-aid highway system, transit, and freight programs.
- H&K organized meetings for Broward MPO with Senate EPW, House T&I, and DOT to discuss its priorities for the bill.

## 2016 Key Accomplishments

#### » Fixing America's Surface Transportation (FAST) Act (Cont.)

- H&K Assisted in Securing Broward's priorities in the bill:
  - Increased funding for highway and transit programs.
  - For the first time, DOT provides funding for freight projects through the National Highway Freight Formula program and a \$4.5 billion FASTLANE Freight Grant Program.
  - Increases MPO's role.
  - Reinstates Bus and Bus Facilities discretionary grant program.
  - Project streamlining for highways and transit.
  - Increased funding for the Railway-Highway Grade Crossings Program.
  - Creates new Intelligent Transportation Systems (ITS) program for MPOs.
