#### MPO Freight Committee/Freight Transportation Advisory Committee

At the February 11, 2016 Economic Development Advisory Committee meeting, the Committee members discussed how to proceed with the creation of a Broward MPO Freight Committee. MPO staff worked with the consultant team to develop a framework for the proposed Freight Transportation Advisory Committee, including considerations for Committee membership, meeting schedule and work plan in relation to the Regional Freight Plan.

### MOU with Port Everglades and FLL Airport

The MPO Board intends to encourage economic development through the establishment of Memoranda of Understanding (MOU) for the Broward MPO with Port Everglades (Port) and the Fort Lauderdale/Hollywood International Airport (FLL). MPO staff has worked with the consultant team a framework for establishing the MOU. The analysis included a review of previous agreements, and a proposed organizational structure of an updated MOU.
