MPOAC Freight Committee



The Florida Metropolitan Planning Organization Advisory Council (MPOAC) created a *Freight Committee* at the July 2013 meeting. The Executive Director of the Broward MPO, Greg Stuart, was nominated and elected its Chair. The Committee established a Mission Statement to "be the collective forum for the development and promotion of actionable ideas that foster and support sound goods movement planning and initiatives for all Florida MPOs." Over the past two years, under the leadership of Mr. Stuart, the Committee has successfully hosted a variety of educational programs on performance measures, data collection

techniques, public / private partnerships, and project evaluation policies. Over the next six months, the Committee will be producing educational materials for the MPOAC membership.

Broward MPO Local Surtax Subcommittee



Billions of dollars in unfunded regional transportation and other infrastructure needs have been identified in *Commitment 2040* and local capital improvement plans. To solve the funding gap, *Speak Up Broward* examined a half dozen options, concluding that a sales surtax was the easiest to enact. The MPO Chair established the *Local Surtax Subcommittee* at the December Board Meeting to investigate the two sales surtaxes and to coordinate with the Broward County Administrator to identify a list of referendum "must haves." The Subcommittee met several times and developed a framework for discussion on how a one-cent surtax could be allocated.

At the February 11, 2016 meeting, the MPO Board considered many compromise options and chose to move forward with a combination half-cent infrastructure surtax and half-cent transportation surtax as the starting point for negotiations with the County on the subject. At the February 16, 2016 Transportation Workshop with the Broward

County Board of County Commissioners, MPO officials presented their perspectives and the County Commissioners expressed a preference for the Transportation Surtax, with a general consensus that a portion of the revenues should go directly to municipalities.
