MPO Board & Committees

- According to the Interlocal Agreement (ILA) between Broward County and the MPO: the Technical Advisory Committee (TAC), Citizens Advisory Committee (CAC) and the MPO Board are **not** required to take any action on the prioritization efforts by the MPO Surtax Services staff.
- The ILA requires the MPO Surtax Services staff to brief the MPO Board at least twice per year and the TAC/CAC at least four times per year on the **status** of the MPO's work to review, rank, and prioritize municipal projects.

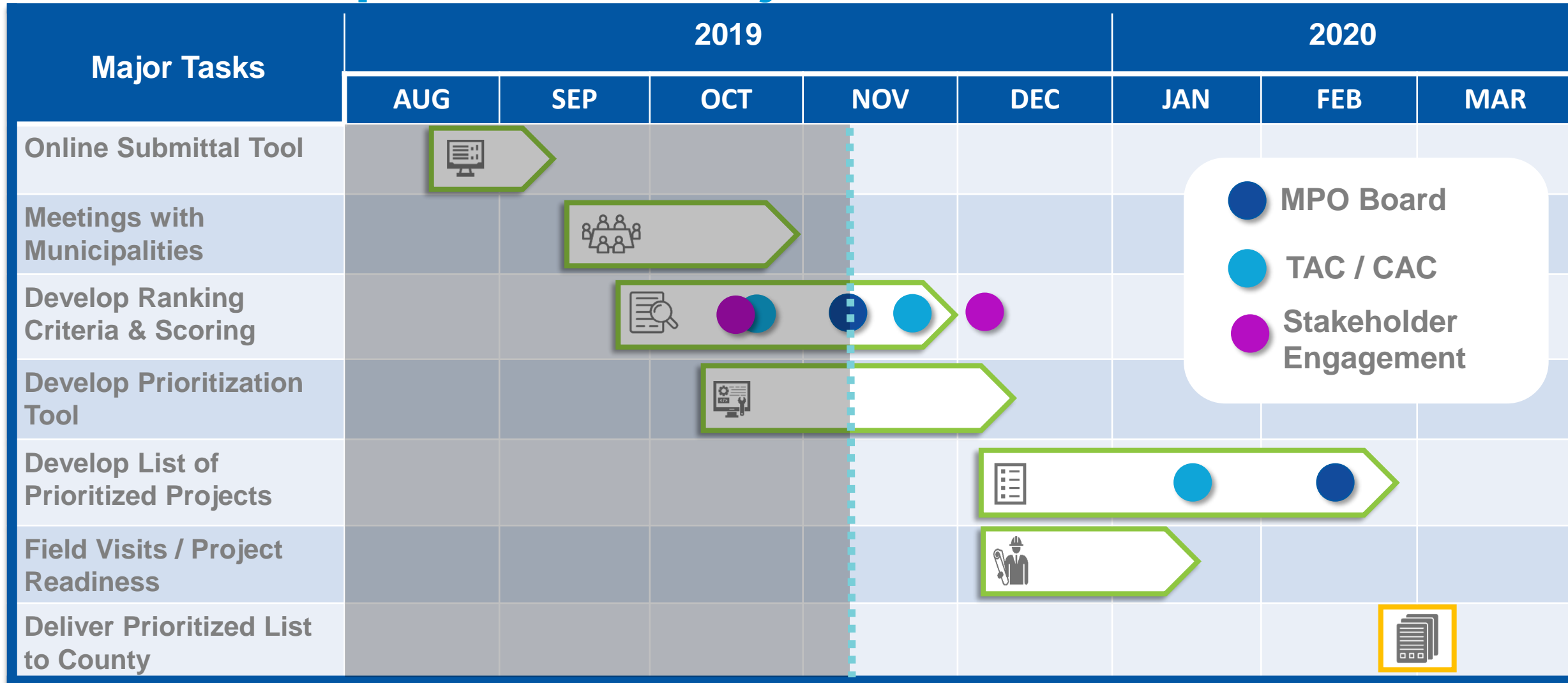

Cycle 1 (FY 2020) County Funding Timeline

- 1 **January 2020** – County Workshop: Municipal Surtax Project Agreements Approach.
- 2 **March 1, 2020** – MPO Deliver Prioritized List to County Staff.
- 3 **March 26, 2020** – Cycle 1 Surtax Projects Presented to Surtax Oversight Board.
- 4 **April 2020** – County Supplemental Budget Resolution to include Cycle 1 Municipal Surtax Projects into FY2020 Budget.
- 5 **Cycle 1 Projects Launch** – Immediately following April Supplemental Budget Resolution (ILA for project funding must be executed).
