UNIVERSITY DRIVE MOBILITY IMPROVEMENTS PLANNING STUDY



The MPO has launched a transportation and livability study for University Drive, one of Broward's most critical north-south corridors. The study area centers on University Drive from Westview Drive in Coral Springs to approximately Miami Gardens in Miami-Dade County.

The final southern study limits will be determined based on additional analysis and coordination with Miami-Dade County agencies. This study was funded by the Federal Transit Administration and is being conducted in partnership with the Florida Department of Transportation, Broward County Transit, Miami-Dade Transit, the South Florida Regional Transportation Authority and the Cities and Towns along the University Drive corridor.

The study will identify solutions to **increase travel options, manage traffic congestion** and will try to improve through its recommendations the **quality of life** along University Drive. A series of potential alternatives to address these issues will be developed and evaluated. The evaluation will include how to best connect different modes of transportation, and where any enhanced transit service may be located, in addition to pedestrian and bicyclist facilities.

The types of improvements this study will explore include:

- **Enhancing the travel experience for all people;**
- **Improving the convenience and comfort of the transit service;**
- **Improving safety and comfort for cyclists and pedestrians; and**
- **Encouraging walkable and transit-friendly development.**

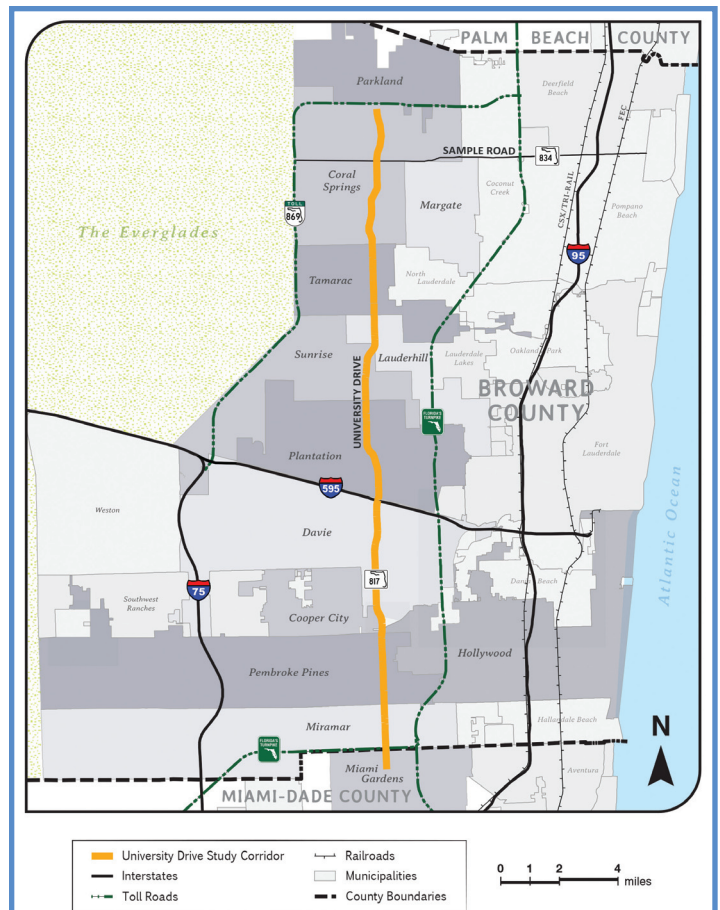

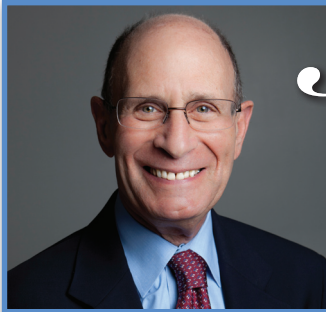

While the MPO meets monthly, and we have Executive and Governance committees, it is still kind of amazing to see the list of projects being undertaken. You will see several of them in this newsletter.

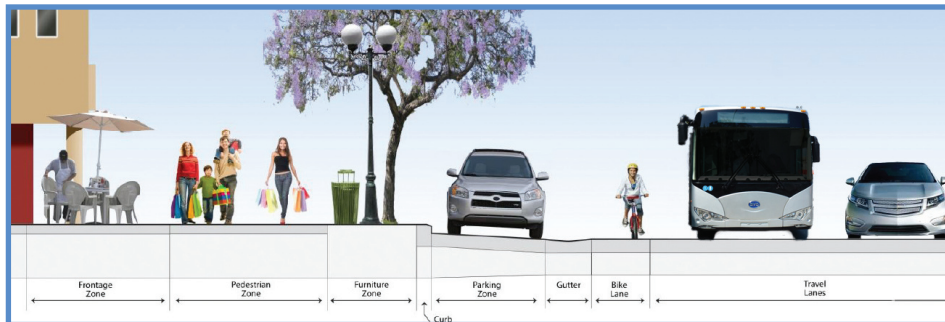
As an independent transportation funding and policy board, our members, representing every city in the county, as well as county government, are mindful of our responsibility to make decisions that positively affect the way people move around; that we keep in mind the need to create jobs and strengthen our communities far into the future. An important consideration in our deliberations is the impact on our neighboring counties. Collaboration and cooperation at this regional level is essential. Our members, our staff and consultants are in close

contact with Miami-Dade and Palm Beach, as well as Tri-Rail, the Florida Department of Transportation, Broward County Transit, Florida East Coast railroad; anyone moving people and goods.

Through "Commitment 2040" and other initiatives we are facilitating conversations with our communities and residents to help us make the best decisions possible. Please check our progress through our website.

As we continue to move forward, it will be important for the MPO to be positioned to compete effectively for limited federal dollars, we will need to reach out to policy makers in both Washington D.C. and Tallahassee. With this in mind, the MPO Board has established an optional local contribution of 5 cents per capita membership fee beginning in Fiscal Year 2014. This membership fee will provide the necessary funds for the Board to ensure we are positioned to compete with other regions throughout the United States.

COMPLETE STREETS IN BROWARD COUNTY



The MPO continues to play a leadership role in implementing Complete Streets in Broward. The vision is to create a safe and efficient transportation network that promotes the health and mobility of all residents and visitors by providing high quality multi-modal (pedestrian, bicycle, transit and automobile) access throughout Broward.

The MPO endorsed the Complete Streets Guidelines on July 12, 2012 to facilitate and assist cities in the implementation of Complete Streets.

It serves as a template that can be adopted, modified, customized, or expanded based on each community's needs and desires.

Currently, a Complete Streets model Policy and a model Plan are being developed. This policy and plan will guide cities in revising their existing regulations to help implement Complete Streets. They will also help identify and prioritize Complete Streets corridors, leading to the funding and construction of projects.

In addition, two demonstration projects have been identified. This is because a "Complete Street" in a suburban area may look different than a "Complete Street" in an urban or downtown area, but both are designed with the same principles. Taking this into account, the two projects selected for analysis are:

Hollywood Boulevard from S. 26th Avenue to Dixie Highway (Urban setting)

Sunset Strip from NW 72 Avenue to NW 19 Street (Suburban setting)

Both of these corridors accommodate all modes of transportation. It is the intent of the MPO to partner with the cities to implement Complete Streets projects. Please visit www.browardcompletestreets.org for additional information.

DISADVANTAGED BUSINESS ENTERPRISE (DBE) PROGRAM UPDATE

The MPO recently updated their DBE Program. It's the MPO's policy to encourage all qualified businesses to actively participate in procurement of all MPO sponsored contracts. The MPO's current DBE participation goal is for 6.1 percent of federal funds allocated through the U.S. Department of Transportation Assisted (FTA)

contracts in the region to be expended with DBEs. The April 2013 updated program is available on the website at the link below and encourages everyone to provide any comments they may have about the program.

TRANSPORTATION IMPROVEMENT PROGRAM

The Transportation Improvement Program (TIP) is a five-year program that prioritizes the funding of transportation improvement projects for the region. COMMITMENT 2040 UPDATE

The MPO hosted a series of workshops (pictured, right) throughout Broward as part of **Commitment 2040**, its Long Range Transportation Plan (LRTP). By utilizing a unique real-time polling method, the public was able to give their input and help shape the future of transportation in the county and the region.

A total of 18 Board members and 84 members of the community engaged with representatives of the MPO and answered a total of 34 questions covering a variety of topics. These questions allowed workshop attendees and elected officials to make difficult decisions regarding the future of transportation in Broward. The result of the real-time polling is available on the **Commitment 2040** website, where you can find updates on the transportation plan.

In addition to the interactive presentations, attendees were given the opportunity to answer the **Commitment**



2040 survey online or in writing. Over 1,100 respondents have given their input via the project's "travel experiences" survey. If you were not able to attend the workshops, there will be more opportunities to get involved. We will continue to host meetings and distribute surveys throughout the summer and fall as the plan develops.
