### **SUMMARY OF EVENT:**

- The purpose of the event was to present "Speak Up Broward" to members of the SR 7 Collaborative and to engage them in a discussion about Speak Up Broward; to encourage them to engage with the MPO to promote the conversation about the current and future transportation needs in their respective communities; recruit them to the speakers bureau; and to identify new presentation opportunities.
- ✓ This is a group that is informed about countywide transportation services.
- During the discussion following the presentation the audience shared the following comments:
  - Bike lanes are not safe.
  - What emergency funding sources are available for residents who cannot get to work?
  - Broward County dramatically reduced its funding to cities for community bus service. Cities do not have the funds to improve or increase services.
  - Access to Broward Transit services is a problem. The service should not be more than ¼ mile from the residence or neighborhood to the bus stop.
  - Mario Aispuro, Broward County Urban Planning Redevelopment Department, provided the group with a historical overview that lead to the County reducing its contribution for community bus service.
- ✓ The audience completed surveys.
- ✓ There was a call to action by Pamela; she asked the audience to recommend HOA's,
