### **SUMMARY OF EVENT:**

- Dave Wallace introduced Speak Up Broward with the "Let's Talk Transportation" presentation.
- ✓ Following the presentation, the audience voiced many concerns about the current transportation system and future plans. Comments made included the following:
  - Broward should have a metro rail like Miami.
  - $\circ~$  The bicycle lifts on the buses are very helpful. You can get to work using the bus and bike without getting sweaty.
  - Broward should have a "zip car" program like other large cities (Miami, New York) so people could use public transportation more often and have access to a car at bus terminals.
  - Bus routes are not efficient it need to be improved. (I don't like to drive but the routes are not direct, too many connections to get to desired destinations).
  - The cost of public transportation is expensive if you have a large family. A daily pass is \$4.00 per person and if you have four children it cost \$20.00 for the day and it takes too long to get where you are going.
  - A child's fare is based on height versus age in Broward. Other cities such as New York the fare is based on age. Families with tall children are penalized.
