SUBJECT: **YEAR 2011 TRANSPORTATION ENHANCEMENT PROGRAM CYCLE**

The Broward MPO is pleased to announce that approximately \$4.2 million of Transportation Enhancement (TE) grant funds are available for the 2011 cycle. The minimum TE grant award will be \$250,000 with potential maximum awards of \$1 million.

An Enhancement Workshop is scheduled for Friday, March 4, 2011 at 9:00 a.m. at the Broward MPO offices, at 100 West Cypress Creek Road, Suite 850. All potential applicants and interested parties are encouraged to attend this informative workshop that will feature presentations by FDOT, District 4 staff and Broward MPO staff. Outstanding Transportation Enhancement projects funded in previous years will also be discussed with respective municipal representatives. A list of those projects will be sent under separate cover.
