Let's Go Walking! 2018


Over 70 people attended the 2018 Let's Go Walking! event held on Saturday. October 20, 2018 in the City of Wilton Manors. This walking event was the Broward MPO's 3rd annual event and for the first time was hosted in conjunction with another community event, the Wilton Manors Arts and Entertainment Expo. The event provided not only an opportunity to walk around the area and



see Complete Streets improvements, but to learn about the different assets that the City has to offer. Community partners and local business participated in the event and after the walk participants took advantage of the activities provided by the Expo, such as local artists selling merchandise, music, and local resturaunt deals.

Walking Audits

The Broward MPO has been conducting a series walking audits analyze to potential improvements on corridors that are included in the Complete Streets Master Plan. Two have been conducted so far. The first walking audit was held in the City of Lauderhill on the afternoon of September 27, 2018 and highlighted the conditions of Oakland Park Boulevard from University Drive to Inverrary Boulevard. The second was in the City of Deerfield Beach on the morning of Saturday, November 3, 2018 and analyzed Dixie Highway from Sample Road to County Line. The walking audit data will help inform the scoping for upcoming improvements



Slido Polling Results



In addition the walking audits help to build some support and encouragement for the Complete Streets improvements and open a dialogue with the local community about the needs and concerns along each route. There will be one more walking audit in 2018 and another two to be scheduled for 2019.

Training Opportunities

Based on the popularity and success of the first ADA workshop, the Broward MPO with Kimley-Horn and Associates will be conducting a series of ADA transition plan workshops. The next one titled ADA Workshop 2.0 will be held on Thursday, November 15, 2018. This workshop will be informed by the feedback provided by participants of the first workshop. The training will cover a transition plan roadmap, introduction to standards and technical resources, proposed accessibility guidelines for Pedestrian Facilities in the Right of Way (PROWAG), and include a design considerations breakout.



2019 Safe Streets Summit

The 6th annual Safe Streets Summit will take place on February 25 and 26, 2019 in Miami-Dade County. The theme for 2019 is "Safe Streets, Smart Streets," bringing a focus on the implementation of innovative transportation efforts that address challenges of the future. This year's Summit will seek to inspire decision makers and agencies to implement multimodal transportation solutions that expand travel options through first/last mile connections to transit and will emphasize the importance of actively incorporating equity and inclusion throughout all efforts. The second day will be the mobile workshop portion of the Summit and will include 5 different tours for participants to choose an option based on their interests.

Broward County STAR Certification



STAR stands for Sustainability Tools for Assessing and Rating communities. STAR is a rating system for sustainability framework and it's a certification program for local government and for areas. It is kind of like LEAD but for whole communities as opposed to buildings. It is a way to look at an areas sustainability efforts both at actions and policies, as well as to access the outcomes of those actions.

Broward County is currently a four-STAR community and one of 170 certified communities. Broward County was actually part of the pilot year for STAR and we helped to implement this whole rating system back in 2014. It was a big achievement for Broward County to be amongst the first in the nation to achieve this distinction of being a four- STAR community.

In order to complete the STAR certification, it takes a broad spectrum of agencies and stakeholders to collaborate together and to share data with each other. It's a huge undertaking with hundreds of performance measures, actions, and outcomes involved to complete the report in order to get the certification. Every five years, you have to go through a recertification process. For Broward County the certification is up in 2019, so we've currently been going through the effort the last several months to get recertified in January for another five years of being a STAR-rated community.

Transportation is an extremely important component of the STAR goals and objectives. Transportation Choices is an extremely important component as it is connected to many of the other elements. There are transportation-related questions throughout many other areas including Aging in the Community, Climate Adaptation, Active Living, etc.



Broward County is receiving 51% of the points in the transportation area of STAR certification. The County is doing well in the action area but need to improve in the outcomes area to show if actions are resulting in meaningful change.

• Areas for improvement for outcomes:

Though there is a shortfall in meeting any of the outcome points, Broward County can maximize the points received in the action points to make sure we have all the policies possible to get every point. The two missing: (1) Increase the mileage of sidewalks, particularly on arterial roads that connect people to destinations and (2) Increasing the mileage of buffered bicycle lanes, cycle tracks, parallel street paths, or dedicated facilities. We need help from the Broward MPO to get some of this data so we can get the points for this category.

FLIPANY

FLIPANY stands for Florida Introduces Physical Activity and Nutrition to Youth. We serve in the Tri-County area and our mission is dedicated to empowering youth and adults through nutrition and physical activity programs and also by trying to influence policy changes that create healthier communities, primarily in low-income areas. FLIPANY implements our mission through a variety of innovative programs. The innovative programs aim fight childhood obesity and hunger through focusing on healthy food preparation, food security, food access, community education, physical education and worksite wellness. One of those programs is the Earn-a-Bike program:

What is EARN-A-BIKE?

Earn-A-Bike is a hands-on learning and earning program for youth ages 10-17.

Learning: Over 8 sessions participants learn basic bike repair, maintenance, and safety.

Earning: Graduates receive a bicycle, helmet, and lock and the completion of the course.

EARN - A - BIKE Objectives

- Job Skills: Youth gain hands-on experience in repairing and properly maintaining a bicycle.
- Community Safety: Increase students' knowledge of bike safety and basic laws of riding/driving.
- · Life Skills: Youth participate in team building and leadership activities related to biking.

FLIPANY is looking locations to host the program; in addition the other needs include identifying additional funding sources, bikes, instructors, kids to teach.

FDOT D5 Robinson Street Cycle Track Project Presented by Nathalie Rodriguez and Fabian De La Espriella, Kittelson & Associates

The Robinson Street project is a street redesign that includes a cycle track. The way to relooked at this redesign and other Complete Streets projects is to analyze patterns and how corridors can better function for the surrounding communities. It is important to understand the "bones" of a city and how this influences mobility, connectivity, and quality of life.


The Robinson Street project in Orlando is a 2.3 mile corridor, with limits from Hughley Avenue to Maguire Boulevard. The typical section is approximatley 60 feet for the entire

corridor. There are four lanes, 9.5 feet wide with a 5 foot buffer and then 6 foot sidewalks. There are no medians throughout the entire corridor. The length of the project goes through multiple different areas each with very specific characteristics. One design was not going to meet the needs of each of the districts along the corridor.

Within the areas of the corridor, there is population of 43,000 of those 42% are millennials and there are over 149,000 jobs. The different characteristic districts were split into four sections to create better designs for each area. The different district sections include:

- Central Business District: downtown businesses
- Lake Eola District: park, office buildings, lake, family housing
- Neighborhood District: mainly smaller businesses but some are housing conversions and then all residential
- Milk District: milk factory, commercial

During the public input phase it was determined that a lot of people are utilizing bikes to go to work but there are safety issues that exist currently on Robinson Street, including no medians, no bike lanes and four traveling lanes. There are different design alternatives for for each district. Some of the main element include, mid-block crossings, exclusive bike lanes, shared use paths, raised bike lanes, lane reductions, some signalized and some non-signalized crossings, and speed reducations from 35 to 25.



The project is its final phase of design and is planned to be implemented in early 2019 as part of an already scheduled resurfacing, restoration and rehabilitation project.

Action Item: Request for more detailed information on challenges faced such as how to coordinate across bike paths and buses.
