
Broward MPO Current Effort

Federal Certification 2019

Every four years the federal government does a review of the Broward MPO's internal processes and operations. On April 8 and April 9, the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) conducted their review, focusing on the areas of Transportation Performance Planning, Transit, Planning for Now and the Future, and Public Outreach. The Broward MPO has been recognized as a best practice for the past two certifications and hopes to continue to set an example in the 2019 review. Complete Streets Design Guidelines 2.0

The Broward MPO and Kimley-Horn are working on a newly revised Complete Streets Design Guidelines 2.0. This update complements the Broward Complete Streets Guidelines, 2012. It includes details about FDOT's context classification system, the Complete Streets Master Plan, and new bicycle design facility types. 
Meeting Presentations

Vision Zero Plan - Hillsborough MPO

Gena Torres has been serving Hillsborough County MPO for close to 30 years. She is currently the Vision Zero Manager for Hillsborough County MPO. Vision Zero is a grassroots effort in Hillsborough with a goal that zero traffic fatalities are the only acceptable standard. The initiative started after a series of fatal accidents occurred in the County over a short period of time. Following the accidents, the Hillsborough County MPO sponsored a student peer to peer 30-second video contest where children and young adults discussed their issues with pedestrian safety.

After the series of accidents, a Vision Zero Coalition was created which consists of over two-dozen members dedicated to pedestrian safety using low cost and quick initiatives. The Coalition collected baseline data and put together a Vision Zero Action Plan. Through these efforts it was realized that Hillsborough County had very high fatality rates in comparison to many other localities within Florida. In the development of the action plan, the Coalition



conducted a policy scan of other Vision Communities and compiled a list of lessons learned that was included in the themes of the plan:

- Victim blaming is not helpful
- Storytelling is central
- Zero is the right number
- Reducing speeds is critical
- Traffic violence is a public health crisis
- Needs to be a data-driven approach

The Vision Zero Action Plan has several elements described as the four action tracks. Each element has two corresponding goals. One element is the Future is Not the Past where local governments rely on data such as pedestrian fatalities, but also examine policy and procedures that may hinder safety.

Vision Zero Action Plan • Future is not like the past • Consistent & Fair • Paint Saves Lives • One message, many voices

The next element is Consistent & Fair, which has two corresponding goals to: a) leverage capabilities and existing resource such as the Community Traffic Safety Team; and b) establish a Vision Zero Consistent & Fair Program. The next component of the plan is Paint Saves Lives. Paint Saves Lives has a goal of raising driver awareness of people walking and biking by using high visibility paint in addition to implementing lowcost treatments to improve the safety of a roadway. The last element is One Message, Many Voices, which focuses on increasing awareness of Vision Zero and safe walking and biking behaviors and also engage with victims families to be a part of the efforts.

Next Steps for Hillsborough's Vision Zero

- a) Track performance through quarterly report
- b) Form or partner with a non-profit because of limitation under a government agency
- c) Form an executive board
- d) Partner with local organizations

Safe Routes to School Program - Broward County Public Schools

The Safe Routes to School (SRTS) programs are funded by FDOT to make infrastructure investments for children/students to walk or cycle. The process is competitive and awarded at the local level, by the FDOT district offices. An applicant may submit up to five projects within a single funding cycle, with a minimum threshold is \$250,000. Eligible projects include pedestrian and bicycle facilities and traffic control measures.





Broward County Public Schools (BCPS) can support a cities efforts to apply for SRTS funding and work as a liaison between the city and specific school. Activities can include assisting with getting the schools to collect and report the student travel data, which is required for the SRTS application. This helps to gauge preferred modes of travel to school. In addition to providing the required signature on the application, BCPS can also provide letters of support, participate in SRTS committees, help collect other data points, and assist with reviewing the SRTS application.

Some lessons learned in previous applications:

- Gauge the community interest in the project prior to starting an application
- Obtain the perguisite survey data from schools/parents
- The beginning of the school year is the best time to obtain support from school

BCPS is also working on some future enhancements to their collaboration and assistance with SRTS applications. First, the hope is to create a system that is proactive regarding the status of infrastructure and will work with the cities to collect infrastructure data more consistently. BCPS would also like to build in sufficient lead-time with the School Board, so formal support for the project can be obtained. And the final action is BCPS is working to embark on disseminating the SRTS parent travel data survey across the whole County at the beginning of the school year, so this information is readily available when developing a SRTS application.

Mocking Bird Trail 2.0 - Cadence

The mission of the Mockingbird Trail is to create civic identify, unify the City of Fort Lauderdale's downtown neighborhoods, and improve quality of life through the development of an 8-mile landscaped pedestrian and bike route that links many of the City's local assets. The idea began in 2014 as a grassroots effort to create a neighborhood trail and has evolved over the years into a multi-neighborhood connector. Recently, the organization established a non-profit on the behalf of the proposed Mockingbird Trail expansion. The Mockingbird Trail kicked off the expansion proposal in January 2019 with the most recent public art element being a multisensory mural created in partnership with the Lighthouse of Broward.

The proposed 8-mile expansion is unique in that the route is not designed in a linear orientation, rather it is a network of trails based on existing community assets. It hopes to connect:

- 14 neighborhoods
- 17 public parks and plazas
- 8 multimodal options
- 12 grade schools
- 11 government services
- 5 leisure entertainment districts
- Many historical and cultural sites

The trail aims to transform the City of Fort Lauderdale's residents' pedestrian and biking experiences and integrate many of the goals outlined in local Complete Streets efforts.



Next steps for the Mockingbird Trail include:

- Capital Fundraising
- Public Engagement
- Design & Construction
- Identify Ongoing Maintenance
- Identify Ongoing Programming and Operations
