The Broward Metropolitan Planning Organization (MPO) has begun work on its 5-year update of the Metropolitan Transportation Plan (formerly the Long-Range Transportation Plan) known as *Commitment 2045*. Over the next 18 months, we will work closely with the public, our MPO Board, and our transportation partners to craft a cost feasible plan to address the mobility needs in our region. Identifying and incorporating the capital needs of our transportation partners is a crucial component in the development of *Commitment 2045*.

Meetings held with our member governments in the Summer and Fall of 2017 to discuss needed and planned transportation projects are part of an ongoing process. As a follow-up to the 2017 meetings, we would like to meet with you again to ensure your program ready projects can be considered for the MTP, *Commitment 2045*. Remember, in order for your project(s) to receive federal funding it(they) must be identified in the Broward MPO's MTP.

We recommend working with your elected leaders, the public, and your staff to assemble a list of needed transportation projects, per the format indicated in the flyer, and submit this list to us for review prior to the meeting.
