

### Regional Roadways Prioritized for Walkability




#### Local Roadways Prioritized for Walkability






















The map demonstrates that 6 of the top 8 roadways are N/S roads that intersect with Hallandale Beach Blvd.










## Q6: How you travel: How often do you ride a bike or scooter?





I do not live in the City	Yes	There are three key factors that influence people's comfort and willingness to walk in an area: Safety – Pedestrians need to feel protected from Traffic while using sidewalks and crossing streets. This includes well-maintained pedestrian infrastructure, adequate lighting, elevated crosswalks, and widened pedestrian curbs that reduce exposure to vehicle Traffic. Distance – Walkability efforts should prioritize neighborhoods located near existing walkable areas, as most people are only willing to walk a limited distance. Alternatively, introducing convenient shopping and service options within residential neighborhoods—particularly those lacking nearby retail access—can help foster walkable communities. Temperature – Lowering the ambient temperature through increased shading is essential. trees, shaded walkways, and other cooling design elements greatly enhance walking comfort, especially in warmer climates.
NE	Yes	- Marketing/advertising for local public transit is needed to make residents aware -Protected bike lanes -Wider sidewalks and smaller roadways -More 4 way stops -patching of major potholes
NE	Yes	Bike lanes and walkways are desperately needed as well as more speed enforcement on Hallandale Beach Blvd and throughout the 3Islands neighborhood
NE	Yes	Dixie Highway has no sidewalks, but regardless it is also about the CRIME on US1, Dixie and Pembroke. People are afraid to walk or ride their bikes because of what sits and hangs in the bus stops. You'd be crazy to take public transportation. The bus stops smell like urine and you can't sit down because people are sleeping on the benches.
NE	Yes	I love the Cloud Bus! Buses are clean and efficient. Drivers are courteous and friendly. I wish police would crack down on vehicles with excessively loud exhaust systems. It is noise pollution. A real problem in South Florida. I noticed it a lot here throughout Hallandale. Please ticket these vehicles, raise money for the city and save our citizens hearing. I feel strongly about this.

NE	Yes	"Traffic calming" plan needs to be implemented for Three Islands Bl. after sewer/water project.
NE	Yes	I would like to see more raised crosswalks in neighborhoods with lower speed limits (Ex. NE 3rd St between Dixie and US1), especially in areas where Traffic cuts through and do not pay attention to stop signs/signals. Also, more shaded and native trees along pathways, and more secure bike lanes. People are constantly avoiding the speed bumps along the avenues in the NE section and venture into the bike paths, and I do not feel safe riding my bike along Hallandale Beach Blvd, or any other path in the city for this reason. The Traffic is too fast, people do not obey the speed limit (35mph east of Dixie), and too much pass-through Traffic for people traveling to Dade, avoiding Aventura.
NW	Yes	700 NE 1 Street has become dangerous. My house has been crashed into by cars ignoring the Stop sign or speeding. A solution is a roundabout in the intersection. The roundabout will improve the value to the neighborhood, will improve safety, and create jobs for gardening.
