



FREIGHT ON THE HORIZON: A BOOMING INDUSTRY

Last month, an update to the Southeast Florida Regional Freight Plan was completed with an eye towards future growth. The Broward Metropolitan Planning Organization (MPO), in coordination with Miami-Dade and Palm Beach MPOs, FDOT, the three area seaports (Port Everglades, Port Miami, Port of Palm Beach), the three area airports (Fort Lauderdale-Hollywood International Airport, Miami International Airport, Palm Beach International Airport), the CSX and FEC railroads, as well as a number of private sector stake holders, completed the Plan, which creates a roadmap for the future of the freight industry in Southeast Florida.

Freight can be defined as the commercial transportation of goods, whether by truck, train, ship, or aircraft. One of the Plan's findings was that the freight industry accounts for approximately 278,000 direct jobs in Southeast Florida, with an average salary of \$69,000 per year. Overall, the freight industry has a \$55 billion impact on Southeast Florida's economy. "The financial impact of the freight industry is critical to the economic vitality of Southeast Florida and freight must continue to be an important aspect of the MPO's overall planning efforts," said Paul Flavien, the Broward MPO's Freight Planner.



One of the most crucial improvements made to the Southeast Florida freight infrastructure was the construction of new facilities at both Port Everglades and Port Miami which allows for a seamless transfer of freight containers from ships to trains for delivery. Another critical improvement was the creation of the Port Miami tunnel, which allows trucks direct access from Port Miami to nearby highways.

The updated Plan also uncovered the need for additional truck parking to facilitate freight movement within the region. There are approximately

300 existing truck parking spaces in Southeast Florida; however, the Freight Plan estimates that over 12,000 are needed in order to meet the current and expanding demand.

The success of the freight industry is critical to the future growth and economic competitiveness of the Southeast Florida region. Through the Freight Plan, the Broward MPO and its partners are championing the growth of the freight industry with the objective of making Southeast Florida a globally competitive logistics hub.

MESSAGE FROM THE CHAIR

In their 2014 edition of "Dangerous by Design", the National Complete Streets Coalition ranked four Florida metropolitan areas (including Miami/Fort Lauderdale/Pompano Beach) among the most dangerous in the nation for pedestrians and bicyclists. Through our Complete Streets Initiative, we have allocated \$100 million dollars over the next five years to build an additional 90 miles of bicycle facilities and 35 miles of sidewalks to provide for safer bicycle and pedestrian routes. To augment existing local funding and accelerate the construction of these facilities, the MPO is applying for a Transportation Investment Generating Economic Recovery (TIGER) Grant through the U.S. Department of Transportation (USDOT).



The TIGER program funds transportation projects that provide "significant and measurable improvements over existing conditions." The municipalities with at least one project in the MPO's grant application are: Broward County, Coconut Creek, Davie, Fort Lauderdale, Hollywood, Lauderdale Lakes, Miramar, Oakland Park, Plantation, Pompano Beach, Sunrise, West Park, and Weston.

The Broward MPO Board and staff are committed to creating a safe and efficient transportation network for all residents and visitors, whether they walk, ride a bicycle, take transit, or drive, including those covered under the Americans with Disabilities Act (ADA). We believe this project will result in safer streets and provide better interconnectivity between major commercial, residential, educational, and recreational facilities in the region. USDOT will award the TIGER grants in November.

HOW STREETSMART ARE YOU?

On May 20th, the City of Fort Lauderdale hosted the much anticipated 2015 StreetSmarts Transportation Summit at the Broward Center for Performing Arts. Broward MPO staff, along with other transportation professionals, attended the sold-out event, which covered topics like pedestrian and bike safety, ADA accessibility, and economic development.



USDOT SECRETARY FOXX'S CALL TO ACTION: MAYORS' CHALLENGE FOR SAFER PEOPLE, SAFER STREETS

Broward MPO has officially signed on to participate in USDOT Secretary Anthony Foxx's "Mayors' Challenge for Safer People, Safer Streets." The MPO joins with other cities and municipalities in Florida and across the nation in committing to safety improvements for all modes of transportation. The MPO's participation in the Mayors' Challenge, along with its five-year \$100 million "Complete Streets" program, demonstrates their commitment to improving safety for drivers, bikers, and pedestrians.
