

On November 9th the Broward MPO hosted a workshop to introduce their new, innovative interactive transportation outreach website, initially developed by Miami-Dade MPO. This is a powerful tool to assist transportation planners as well as any professionals that handle public outreach projects. It provides the latest demographic data for Broward, Miami-Dade and Palm Beach Counties from the 2010 Census. It also provides a wealth of information to help professionals fine-tune and customize their public involvement plans with information such as: Points of Interest (for community meeting locations); Customized Demographic Reports; Community Background Reports; and Public Outreach Strategies that are best suited for the selected demographic areas. Florida International University, who assisted the Broward MPO with setting up this website, explained all the aspects of the site and guided the participants through this interactive workshop. The many participants who attended were able to get handson experience right from laptop computers provided during the workshop. Chris Ryan, Broward MPO Public

Information Officer/Title VI Coordinator, emphasized the four R's when preparing a public information plan: Research, Relationships, Resources and Results. He showed everyone how these important components of public involvement can be assisted with the data obtained from this powerful new website. It does not provide an exact plan, but will definitely assist professionals with an excellent starting point for the many decisions that go into public involvement plans. All MPO staff and their consultants will be using this website as a kick-off for all public involvement projects in the future. MESSAGE FROM THE CHAIR




Commissioner Richard Blattner Chair, Broward MPO City of Hollywood, District 4

This interactive site, which is now up and running, was developed by the Broward MPO with Data Transfer Solutions, and is a continuation of the MPO's public outreach efforts. Board members were provided with a demonstration of the interactive site at our November 17th meeting and found it to be very informative and userfriendly. The TIP is a short-term plan that allocates funds over each upcoming 5-year period by project phase. This interactive site directly communicates with the Florida Department of Transportation (FDOT), so project updates are automatic. You can find information about the transportation projects in your area as well as within all areas of Broward County. The site provides user-friendly options, such as the "Search Options" (shown to the right) that will assist you in finding the improvements you are interested in. SOUTHEAST FLORIDA FREIGHT SUMMIT

On November 18th the Southeast Florida Freight Summit was held at Port Everglades. Many people attended from both the local and private sectors to hear how Florida is being impacted by the global trade and logistics industry, as well as the many opportunities this industry brings to Southeast Florida. Speakers included Phil Allen, Director of Port Everglades; Jeff Weidner, Florida Department of Transportation; Carrie Blanchard, Florida Chamber Foundation; Lenny Feldman of Sandler, Travis & Rosenberg, P.A.; and Bob Romig, Interim Assistant Secretary of the Florida Department of Transportation. There was also an interesting panel discussion on Intermodal issues with Phil Allen; Dorian Valdes, Assistant Director of the Port of Miami; Manuel Almira, Director of Carload Marketing & Sales, FEC Railway; and Manuel Gonzalez from the Miami International Airport. Jim Murley, Executive Director of the South Florida Regional Planning Council spoke about the Sustainable Communities Initiative, which provides Southeast Florida with an opportunity to build on its local and regional plans, capitalize on its successes, learn from past experiences, and forge a real regional alliance for the future. Overall, the summit emphasized the opportunities


that Florida has within their ports, freight lines, and airports with respect to trade and the logistics of how goods are transported into and out of our State. We must coordinate regionally on this matter and the Broward MPO is just one of the many partners involved in these coordination efforts. CENTRAL BROWARD EAST-WEST TRANSIT STUDY UPDATE

This study is being conducted in partnership with the Florida Department Transportation of District 4, Broward County Transit, the Broward MPO, and the South Florida Regional Transportation Authority. The purpose of the study is to provide high-quality, highcapacity transit service on an eastwest axis in central Broward County to connect western Broward County with the higher density coastal

areas. The study team presented to the Broward MPO Board earlier this month and has conducted public outreach meetings as well as refined the alternatives. Two alternatives are being considered: Griffin Road and SR 7/Broward Boulevard, both would serve as an extension to *The Wave*, providing streetcar connections to the Broward Boulevard Tri-Rail Station, the Fort Lauderdale-Hollywood International Airport and the Griffin Road Tri-Rail Station from downtown Fort Lauderdale. The study is following the federal transit project development process with a preferred alternative selection by the MPO next summer. The next step will be a **National Environmental Policy Act (NEPA)** review and an environmental document will be prepared. Below is an estimated timeline.



BROWARD B-CYCLE LAUNCHES IN THREE CITIES



Broward County launched its newest mode of public transportation with Broward B-cycle on December 14th in Hollywood, Fort Lauderdale, and Pompano Beach. This exciting day marked the first county bike sharing system in the nation and the first tri-city launch of its kind. Broward B-cycle is an affordable, clean and simple way to get around town. Users can check out a bike from any self service station and return it to any other station nearby. The B-cycles are equipped with a GPS system that tracks mileage, calories burned and carbon offsets. To access the bikes, register on www.broward.bcycle. com or use a credit card at the selfservice kiosks (B-stations). Users must be 18 years or older with a valid credit card. The kick-off began in Hollywood in the morning, then continued in Fort Lauderdale in the afternoon at Esplanade Park and

concluded at the Pompano Beach Broward County Aquatic Center. Vice Mayor and Broward MPO Board member Commissioner Kristin Jacobs spearheaded the initiative to bring bike sharing to Broward County. B-cycle is a partnership among Trek Bicycle, Crispin Porter + Bogusky and Humana, Inc., one of the leading health care companies in Florida and a sponsor of Broward B-cycle.
