



NOTICE OF PUBLIC MEETINGS FOR PROPOSED AMENDMENT TO THE BROWARD MPO COMMITMENT 2045 METROPOLITAN TRANSPORTATION PLAN (MTP)

PUBLIC NOTICE is hereby given that the Broward Metropolitan Planning Organization (Broward MPO) will hold public meetings, providing the public with three opportunities to make verbal comments on proposed amendments to the 2045 Metropolitan Transportation Plan:

- Technical Advisory Committee on Wednesday, January 24, 2024 at 2:30 p.m.
- Citizens' Advisory Committee on Wednesday, January 24, 2024 at 6:00 p.m.
- Broward MPO Board on Thursday, February 8, 2024 at 9:30 a.m.

All meetings will be held in the Broward MPO Board Room, located in the Trade Centre South Building, 100 West Cypress Creek Road, Suite 650, Fort Lauderdale, FL 33309 to consider action on the items below. Amendment to the 2045 Metropolitan Transportation Plan (MTP) to include the following:

- Amend Cost and Timeframe in the MTP I-75 Interchange @ Pines Blvd Project (Roadway Reference ID #4)
 - o Cost: <u>from</u> "2025: \$67,248,000 <u>to</u> "2026-2030: \$151,957,654".
- Amend Description and Timeframe in the MTP I-95 S of Commercial Blvd to Cypress Creek Rd Project (Roadway Reference ID #48)
 - Description: <u>from</u> "I-95 S of Commercial Blvd to Cypress Creek Rd (Add Highway Capacity)" <u>to</u> "I-95 S of Commercial Blvd to Cypress Creek Rd (Interchange Justification/Modification)".
 - Cost: <u>from</u> "2031-2035: \$202,104,000" <u>to</u> "2025: \$367,947; 2026-2030: \$60,000; 2031-2035: \$201,676,053".

- Amend the MTP to <u>add</u> project to the Illustrative Plan Broward County Aviation Department Intermodal Center (IMC) Project (Transit Reference ID #8)
 - Description: "8-level parking garage providing approximately 4,500 parking spaces including a bus transfer area, transit center and connection to future Automated People Mover"
 - o **Cost:** "2025: \$30,000,000; 2026-2030: \$ 784,435,000.
 - Note: Total project cost estimated at \$835M* (with design and construction phases funded through a combination of local funds and federal and state grants; *funds expended prior to 2025).
- Amend the MTP to <u>add</u> project to the Illustrative Plan Broward County Aviation Department Automated People Mover (APM) Circulator Project (Transit Reference ID #9)
 - Description: "elevated guideway and train system connecting the airport's terminals, existing parking garages, Rental Car Center, and the future Intermodal Center in a closed loop with up to six stations and a Maintenance and Storage Facility."
 - o **Cost:** "2025: \$122,900,000; 2026-2030: \$ 643,275,000.
 - Note: Total project cost estimated at \$855M* (with design and construction phases funded through a combination of local funds and federal and state grants;
 *funds expended prior to 2025).
