Project Background: Goals and Objectives

GOAL

Produce a locally supported conceptual design for the segment of SW/SE 17th St, from SW 9th Avenue to US-1, that provides safe and comfortable bicycle and pedestrian facilities complementing the proposed Broward Commuter Rail Station.


Objectives:

- Enhanced bicycle and pedestrian safety.
- Increase Walkability and Accessibility.
- Increase connectivity from residential areas, businesses and schools to transit.





Project Background: Project Boundary





Project Background: Project Assumptions

- The proposed PREMO Light Rail Transit along this corridor is represented as **at-grade**, **mixed traffic curbside LRT** with a 12-foot outside lane as the potential transit envelope.
- New Proposed Crossings will be considered as **Raised Crossings**
 - Both Alternatives show crossings at the same locations
- Looking at opportunities to extend median noses for pedestrian refuge islands
- Inside lanes for alternatives will be proposed as 10-foot inside lanes, per city request
- Other considerations that will be made throughout the roadway are:
 - Landscaping/hardscaping
 - Lighting
 - ADA compliant facilities
 - Pavement markings
 - Signage
- This project does **NOT** include any improvements to the FEC property








SW 4 Ave to US-1 Alternative 1











FEC Railway to SE 3rd Avenue




Between FEC Railway and S Andrews Ave Section B




Between S Andrews Ave and SE 3rd Ave Section C




SW 4 Ave to US-1 Alternative 2

2-way cycle track












FEC Railway to SE 3rd Avenue




Between FEC Railway and S Andrews Ave Section B



Between S Andrews Ave and SE 3rd Ave Section C




