



DISTRICT FOUR PROJECT OVERVIEW

Florida's Turnpike Enterprise continues to make significant project investments in District Four. In FY 2017 and FY 2018, current Turnpike projects total over \$490 million within Broward, Indian River, Martin, Palm Beach, and St. Lucie Counties.

Widen the Sawgrass Expressway / SR 869 between Atlantic Boulevard / SR 814 (MP 8) and SR 7 (MP 18) FPN: 435461-1,-2

The project widens a segment of the Sawgrass Expressway / SR 869 between Atlantic Boulevard and SR 7. The widening will increase the number of travel lanes from six to ten. The new lanes will be express lanes. Work includes pavement widening, reconstruction, milling and resurfacing, and interchange improvements. Project Length: 10.6 miles

The project widens a segment of the Sawgrass Expressway between SR 7 and Powerline Road. The widening will increase the number of travel lanes from six to ten. The new lanes will be express lanes. Work includes pavement widening, reconstruction, milling and resurfacing, bridge construction, and interchange improvements. Project Length: 3.0 miles

Interchange Improvements at the Turnpike / Homestead Extension (SR 91 / SR 821) Spur (MP47) FPN: 439742-1

The project is proposed to provide express lane direct connections and associated ramp improvements. The express lane connections will provide continuity to the regional express lane network from the Turnpike (SR 91) to the Homestead Extension (SR 821). Other ramp improvements will be analyzed to accommodate the proposed express lane direct connections. Project Length: 1.6 miles

The project resurfaces a segment of the Turnpike / SR 91 between the Miami-Dade/Broward County Line (MP 47) and the I-595 interchange (MP 54). Work includes milling and resurfacing, guardrail installation, and signing and pavement marking improvements. Project Length: 7.0 miles

The project is a PD&E study that will evaluate widening a segment of the Turnpike / SR 91 between I-595 and Atlantic Boulevard from eight to ten lanes. The study will also examine potential new interchanges at Cypress Creek Road and Oakland Park Boulevard. The new lanes will be express lanes. Work includes pavement widening, reconstruction, milling and resurfacing, bridge construction, and interchange improvements. Project Length: 3.0 miles

Implement All-Electronic Tolling (AET) Phase 8 on the Turnpike / SR 91 FPN: 431737-1

The project implements Phase 8 of an overall program to convert portions of the Turnpike System to a cashless, allelectronic toll collection system. The limits of AET Phase 8 conversion project begin at Lantana Toll Plaza (MP 88) on the Turnpike / SR 91 in Palm Beach County, and extend north through Martin, St. Lucie, Indian River, and Okeechobee Counties, to Three Lakes Toll Plaza (MP 236) on the Turnpike / SR 91 in Osceola County. The AET Phase 8 conversion project includes the removal and replacement of 30 ramp toll plazas and two mainline toll plazas. Project Length: 148.0 miles


