Pursuant to *Part IV – Chapter 5: Statewide and Local Transportation Improvement Programs (STIP and TIP) of the Work Program Instructions*, the Florida Department of Transportation (FDOT) requests your processing and approval of the attached modification to the FY 2024/25 – 2028/29 Transportation Improvement Program.

This modification is for funds that are being adjusted that do not exceed the 20% AND \$2M threshold which does not meet the criteria for a formal TIP/STIP Amendment and needs to be reflected in the TIP for authorization of funds prior to June 30, 2025. The fund adjustment is for fund type and no change in costs.

These projects are consistent with the goals of the Broward Metropolitan Planning Organization's Long-Range Transportation Plan. The TIP remains financially constrained.
