Action Items

Public Participation Plan (School Age Children)

- 2. Provide information to the Broward County Schools Curriculum Division that provides an overview of the various education programs available such as the TRAC and RIDES program.
- 3. Identify funding and grant opportunities to further transportation and safety education initiatives.

Board Educational Program

- 1. Develop a pamphlet that provides a concise yet comprehensive overview the project prioritization process.
- 2. Develop a 'Transportation 101' glossary or 'wiki' that defines commonly used transportation planning terms and processes encountered by the Board.

Committee Administration

1. Provide committee members and Board members updates on education outreach efforts as they occur so they are aware of what efforts and events are taking place.
